

CITY OF LEEDS, ALABAMA PUBLIC HEARING AND REGULAR SCHEDULED COUNCIL MEETING JUNE 03, 2019

The Council of the City of Leeds, Alabama met for a Public Hearing and Regular Scheduled Council Meeting on Monday, June 03, 2019 at 6:00PM in the Leeds Civic Center Meeting Room, 1000 Park Drive, Leeds, Alabama 35094.

- 1. CALL TO ORDER: the meeting was called to order at 6:01pm by Mayor Pro tem Kenneth Washington. Those present were: Ryan Bell, Johnny Dutton, Linda Miller, Eric Turner and Kenneth Washington. Also present were City Attorneys Scott Barnett and Johnny Brunson. Mayor David Miller was absent. Also present were City Attorneys Johnny Brunson and Scott Barnett.
- 2. INVOCATION AND PLEDGE OF ALLEGIANCE: the invocation was led by Councilmember Turner.

3. PUBLIC HEARING:

- a. Consider Determination of Certain Conditions to be an Annoyance and Public Nuisance in Violation of Chapter 32 of the Code of Ordinances at:
- i. 1760 10th Court
- ii. 8524 Side Trak

The floor was opened for anyone present to speak concerning the properties. Owner David Courson addressed the Council to state that he leases the properties to a used vehicle dealer. Brad Watson, Administrator of Inspections, stated that the notice was sent to the property owner and the tenant. Mr. Courson requested a 90-day extension to allow him to check the VINs (vehicle identification numbers) and send notices before the City has the vehicles towed. Mr. Watson stated that a 75-90 day extension might be allowed, but that a progress report would be required in 30 days.

- iii. 8125 3rd Avenue. The floor was opened for anyone present to speak concerning the property. Mr. James Faulkner stated that the property has been cleared. Mr. Watson confirmed the statement.
- iv. 1233 Elizabeth Street. The floor was opened for anyone present to speak concerning the property. There was no one present and the matter was referred to Council.

c. Z-2019-903: A request for the rezoning of a Certain Property at 1441 West River Drive from R-2. Single Family Residential to INST-1 Institutional District. Shirley Dollar commented that she lives next door and is in favor of the church's request.
